Preliminary remarks

European Union law has changed considerably when the Treaty of Lisbon entered into force in 2009. Therefore it is not recommended for students to use textbooks or other sources that have been published before 2010. The information they contain may be obsolete or outdated.

European Union law is a multilingual legal system. The most important language is French, since the legal terminology and many basic concepts are based on the French legal tradition. The largest number of publications can be found in French, German and English. However, there are numerous publications on European Union law in all official languages of the European Union. Be aware of the danger to develop a biased understanding if you only consult resources in English! Try to work with legal literature in different languages, including Romanian!

H. Internet sources in the field of European law

There are many internet sources which allow an easy orientation and a quick access to the Law of the European Union. For example, you can find *all the founding treaties*, all *EU legislation* and all the *jurisprudence* of the European Court of Justice in the internet. As well, some introductions to case-solving in the field of European law have been published in the internet. See the links on the special website for this course. Concerning the individual policies of the European Union see the special websites of the European Commission (http://ec.europa.eu/internal_market/index_en.htm) and of the EU main server "Europa" (http://europa.eu/pol/index_en.htm).

I especially recommend those internet sources which provide the *same information in different European languages* (see, for example, the website of EuR-Lex, <http://eur-lex.europa.eu>). It is useful to have a look on different language versions and to learn the most important legal terms in various languages. Most times, it is easy to switch between the different language versions. *If possible, the founding treaties should be read in French, Italian or German* because the *English version* has been added later and contains many *unprecise and problematic* passages which often cause misunderstandings. If there is an incongruence between the Romanian and the English version, check the French and Italian version!
